COMES NOW, PETITIONER, Lancelot Armstrong, DC #693504, in the above styled cause and moves this Honorable Court pursuant to Article Section 21 of the Florida Constitution for the issuance of an order directing Michael Moore, Bradley D. Carter, Captain R. Walmsley, to allow petitioner to access to phone use for the purpose of have legal conferences with his legal counsel in reference to his cases pending before the court while on appeal, etc. In support thereof petitioner states the following facts:

(1). Said Telephone Rule presently at the P-dorm unit Death Row stated as follows that any outgoing call on a collect basis only. And must be of emergency or legal status.

(2). Calls of an emergency or urgent nature pertaining to serious illness or death in the inmates immediate family will normally be handled and approved by Chaplain.

(3). All outgoing inmate calls ARE To be Placed on A collect call only basis with NO cost to the institution or the state.

(4). Petitioner has Requested Phone call To Confer About legal issues Pertaining To his cases on sErvAl occassions but was Refused By captain R. Walmsley, Sgt. M. J. Young, And The Chaplain. et. Al. etc. even Law library Sgt. R. U. Tucker on The 8 To 4 shift hindering such Access.

(5). SEE exhibits 1 Thru. 44, which Prison officials Willful And Deliberately Refused to Allow PROPER ACCESS To Phone calls, Further Deliberately Denied Petitioner of his normal INK pens And pencils, etc.

(6). Petitioner NEEDS ACCESS To his normal INK pens And pencils, Petitioner NEEDS ACCESS To The Telephone To Assist And Aid Counsel which Represents his cases, " Petitioner Counsel's And Investigator's And All other legal Assistants working with or in Petitioner cases, etc.

(7). Petitioner needs Access To Counsel By Phone And To Family And Witnesses, Friends And business Forum And Further not limited To Any person or persons which shall Assist with information in Petitioner cases, For The Purpose of Assisting Counsel in obtaining important Tangible Evidence That will Aid Petitioner in win his Appeal, etc.

(8). The foregoing motion is made upon Authority of Florida Rules of Criminal Procedure, Rule 3.220(B)(2) And Brady v. Maryland, 373 U.S. 83, 10 L. Ed. 2d. 215, (1983). And All other DUE PROCESS And Equal Protection of Law Rights And Basic Rights AS guaranteed by both The state And Federal constitutions.

(9). That if Petitioner is continued To be denied Access To normal Ink Pens And pencils, And such denial Access To Phone use To call his Attorney by Respondants. Plaintiff will suffer The Prejudice of being denied his constitution Right To A

Fair And impartial Trial And his Right
To both effective Assistance of Counsel
And To Access To The Court As -
Guaranteed by The 5th, 6th And 14th -
Amendments To The United States -
Constitution .
