## General Affidavit & Theory For Re-sentencing

(Culpability Scope)

1) I Lancelot Armstrong, do hereby swear that the following statement is true and correct and made of my own free will and personal knowledge:

On 2/16/90, at approximately 2-2:30 pm while driving down 22<sup>nd</sup> Avenue & 172<sup>nd</sup> Street, Kengeral Allen and her twin Sister Kendrella signaled me to stop, I did and Kengeral asked me to follow them back to her mother's house which I did. Arriving at Kengeral's mother's home she proceeded to inform me I was the father of her twin daughters, she gave me her new address and requested that I pick her up from work to talk further about the interest of the kids.

Wayne Coleman who was with me wrote down the address. Kendrella asked for a ride to her boyfriend's. Leaving The Allen's mothers home I first stopped at the Flea Market at 183<sup>rd</sup> Street and did some shopping of clothing and household items to send for my family in the Island. I then took Kengrella to 208<sup>th</sup> NW 26<sup>th</sup> Avenue, she asked Wayne Coleman his name who was also with us in the back seat (he had his gun under a towel, I do not travel with my gunton the street) and he told her his name was Bobby. While Kendrella was checking on her boyfriend I asked Wayne why he lied to her and he said, "It is a bad area and it may be a set-up for them to rob me". Kendrella returned and asked me to take her to the Cloverlief apartment which I did. I told them I was not feeling well and in pain and wanted to go home. Kendrella on leaving reminded me to give her sister a ride home from work. Wayne Coleman also decided to visit two girls at the same apartment. He lived in the same area.

I went home to Yvonne at Century Lake Apartment, took some medication, used some icy hot (pain relieving cream) on my back and neck then went to sleep.

Sometime later Wayne called my beeper to remind me to pick up Kengeral from work. I fell asleep again and after a few more calls I used Yvonne's car, picked up Wayne since he wrote the address (I was dyslexis and could

not read) and I needed him to drive as I was still feeling pain from a car accident I was involved in 11/22/89.

Arriving at Church's Chicken in Fort Lauderdale we went through the drivetru and told the woman at the window Lance is here to pick up Kengeral Allen. She told us to park in front and come wait inside until they completed their clean up, she opened the door for us. I tried to buy something to drink but was offered it as complimentary because of who I was.

Kengeral and I went out to the car to talk leaving Wayne inside. I was asked why I am not at my house anymore, I told her my house was shoot up so I stay away. She also wanted to know whose car I was driving, I told her it was a Christmas gift from me to my new girlfriend. She was upset at someone new in my life getting a car from me.

During our conversation the workers started leaving after awhile Wayne came out to the car window and asked if the restaurant made a lot of money as he is going to rob it. I said "no, are you crazy?" and turned back to continue to talk with Kengeral. She asked what he wanted and I told her what he said, she started saying it was not worth it, Wayne got upset and hit me on the side of the head with a gun, ran around the other side of the car and forced Kengeral out by gun point and into the building. I was dazed and bleeding from the blow when I was approached by Deputy Greeney.

- 2) 2/17/90 Deputies Greeney and Sallustio ordered me out of the car in response to a silent alarm.
- 3) Deputy Greeney searched me then the car while Deputy Sallustio covered. No gun or contraband was found from the search so Deputy Greeney moved to the front of the car while I asked why were they harassing me. I tried telling them what happened but was harshly told to be quiet.
- 3) I pointed at Wayne coming out the restaurant and was ordered to keep my hands on the car and to shut up, I complied with all verbal orders from both deputies although I was in a lot of pain maintaining that position. I did not know they understood what I was trying to tell them until Deputy Sallistio stated in the courtroom that he knew I spoke English because I obeyed all verbal commands and spoke to them in English.
- 4) Wayne came running and shooting out of the restaurant and the Deputies returned fire, he kicked the restaurant door open, ran out still shooting and

took cover by the car, Deputy Sallustio turned while shooting then shot me in the right shoulder unintentionally.

- 5) As Deputy Sallustio moved to the back of the building for cover, I followed with my hands in the air for cover also, Deputy Sallustio shot at me again then he acknowledge my hands was still up and lowered his gun; I saw Wayne backing the car out, I went towards him at the front and told him I was shot and needed to go to the hospital. Wayne got out and ordered me to drive while cussing and said he is going to kill that bitch while looking if he saw her so I started driving off and Wayne picked up a box off the front seat and ran in the back seat of the car. At that time I saw Deputy Greeney on the ground not moving.
- 6) I believe since I did not rob Kengeral Allen, and Deputy Sallustio saw that the car and I was clean after the search and I complied with both deputies verbal commands, and did not resist the search etc., the truth would come out sooner or later. All I did was to go to pick up Kengeral from work accompanied by Wayne who had criminal intentions and carried out the action by himself.
- 7) Based on my injury and life experiences I choose to leave the scene to seek professional medical assistance and official advice, and counsel.
