
MOTION AND NOTICE OF HEARING
FOR DISMISSAL

THE COURT'S REVIEW OF THIS FILE REVEALS THAT IT DOES NOT AFFIRMATIVELY APPEAR FROM FILING OF PLEADINGS, ORDER OF COURT OR OTHERWISE FOR A PERIOD OF 120 DAYS AFTER FILING OF THE INITIAL PLEADING, THAT SERVICE OF SUMMONS AND SUCH PLEADINGS HAS BEEN MADE UPON DEFENDANT, JENNE KEN

IF NO SHOWING OF GOOD CAUSE IS FILED WITHIN THE TIME SPECIFIED IN PARAGRAPH ONE (1) HEREOF THIS ACTION SHALL STAND DISMISSED FOR LACK OF SERVICE ON THE DATE SPECIFIED IN PARAGRAPH THREE (3) AND THE PLAINTIFF TAKE NOTHING BY THIS ACTION AS TO DEFENDANT, JENNE KEN WITHOUT PREJUDICE TO REFILE AS PROVIDED BY LAW.
