- ~ Q. If you don't feel comfortable, you don't have to say

 - Q. Okay, no problem and your Social Security Number and again, if you don't feel comfortable, you don't have to say

 - Q. Carr'you describe in detail, how the incident described to you went down with Lancelot Armstrong including all actions taken by you and your response to the incident. Basically, in your words what happened on that night-March 17 or anything leading up to it or ya know, tell me about Lance, what kind of guy he was and basically anything that you can tell me about Lance

and that night and your relationship with Coleman and what went down. I never seen Coleman before that. I never knew his name until they were caught and whatever they said his name on the news, Coleman. I had known Lancelot for a while. 1 don't exactly recall how long I had known him, he was a business type man he done a lot of side jobs. odd jobs, __ for the most part. Q. Can you tell me about exactly, like, in your words what happened that night as far as the that he came to Church's Chicken? A. That night he came up to my job, surprisingly I had called him and asked him for a ride, he came with another gentleman before I had finished completely closing the restaurant down. one of the gentleman, which was Coleman, in the dining room went outside and sat in the vehicle talking to Lance. Lance ... Q. When you were talking to Lance, just you two were in the vehicle? A. Yeah. Q. What were you guys talking about? A. The paternity of the twins... As far as Yeah. um, we just discussed a few things and mainly the kids but anyway we switched subjects really fast and he told me, asked me to do something which I changed his mind. Q. Asked him to? Asked me to: To do? Q. A. Wanted me to go into the restaurant like nothing was happening, get the money and bring it out. I said no and I asked him was he gonna jeopardize everything for pennies, for the little nothing that

we	had in the register. He changed his mind really fast.
Q.	So you explained to him that it wasn't worth it because, you are only talking about
A.	Nothing, don't risk his life for nothing
Q.	And he kind of agreed with that?
A.	Yeah.
Q.	Okay.
A.	Coleman came out of the restaurant and I told him I was not down with anything like that
Mr.	. Coleman pulled a gun from his waistband, told him to wait or get back or whatever, and said

Q.	So when Lance told Coleman that we weren't going to do the robbery that he pulled out a
	gun and said Yeah we are get back in the car and basically took control of the situation.
	Okay, so what did Lance say when he had the gun pulled on him, did he say anything?
A.	Don't hurt me
Q.	Don't hurt you
A.	Don't hurt me, ya see, when I seen Coleman and I seen his eyes I knew it was no backing for
	this guy
Q.	He looked very
A.	He looked very aggressive, he looked like there was no persuading him not to do it and he
	was and wasn't changing his mind
Q.	Do you think maybe he could have been under the influence of some kind of narcotic or
	alcohol or
A.	Coleman looked like he was under the influence of something, he really looked
Q.	Okay, and then I guess what happened

A.	At that time there was no employees there, he, Lance came in with him, he was
	forcing me to open the safe, I thought I was going to die that night.
Q.	You thought you were going to die, you felt
A .	I knew I was gonna die that night
Q.	So, it was just you and Coleman inside the restaurant, he ordered Lance to say in the, by the
A.	I don't know he did focus on me first after he got the money, he told me to come from
	in the office and lie face down on the floor.
Q.	That's when
A.	That's when I knew it was gonna happen
Q.	Did you think if the police didn't show up
Α.	I know if they hadn't shown, he would have killed me, I know if they wouldn't have came
	. I would have been killed. I know that. I think that Coleman would have killed anybody in
	his way that night. Everyone and anyone. He told me, don't get up, so I was walking in front
	of him with my hands up to the sky when I asked, Coleman fired one shot of which
	I heard like a whistle close to my head.
Q.	So did you see the police pull up
A.	I seen the police still walking towards
Q.	Officer Sallustio walking towards
A	Walking towards the window
Q.	And then Coleman pulled out the gun and fired
A.	He had it out the entire time, he never put the gun back. In fact, it was towards me, which
	I was in front of Sallustic and I just started screaming and took under the table and come and

ran back behind where the ____ was and the windows were and starting firing shots and then

I hear the shots coming in and out and a lot of policemen started coming and they grabbed

me from under the table. If is wasn't for that one cop

- Q. The other police officer
- If it wasn't for Coleman firing shots
- Q. Yeah, that started this off, the whole gun battle. At any time did you see Lance firing any gun or
- A. No I did not see him firing a gun, he carried a firearm for his protection
- Q. And at no time did you ever witness him during that night pick up a gun or fire
- A. I never noticed him firing a gun, but he did pull a gun from under the seat, he had a gun up under the seat
- Q. I guess what would be the next, so there was a lot of firing of guns
- A. A lot
- Q. A lot, how long do you think the fire fight went
- A. Maybe five or ten minutes if that, maybe five, ten minutes, if that.
- Q. And then do you know what happened then, after that, or you where underneath this table and a police officer came to help you, assist you
- A. Coleman was in firing the shots and then he ran out and then came back in and he told me to shut up, make him think I was hit or something I don't know, but I just stopped screaming. I was totally quiet because he was running back and forth, he ____ in the kitchen area, outside, back in, I'm like, I don't know, I don't know
- Q. I guess the fire fighting stopped and then
- All went silent

- Q. And then what happened next, did you hear anybody talking, was Coleman saying anything or
- A. I didn't hear any more noise, the next think I heard was the police officers that came inside
- Q. So I guess then Coleman left and that's all you heard. Okay, so you think definitely the aggressor then of this whole incident was Coleman.
- A. I know the aggressor was Coleman, I told him I wasn't down with that, he should have just left.
- Q. And that was the first time you ever met Coleman, that night
- A. The very first time and I had ever met him. Yeah, very first time.
- Q. And could you describe what Mr. Coleman was wearing that night or is there anything else you would like to say about the character of Mr. Armstrong as far as, I don't know, like what kind of character he was, was he a person that was, that would help out people, like give rides or was he not that type of person, or just kind of like the character of Mr. Armstrong as far as your relationship with him.
- A. For the most part he was humble, generous, he just got mixed up with the wrong people. I don't know, once I seen him in a jealous tone, I did not make much of it, I guess I was young and didn't think too much of it. I like surprised me but when he backed off, that didn't surprise me.
- Q. So as far like him trying to stop the whole thing, that's in character of Mr. Armstrong
- A. Yes
- Q. As far as when you testified in court in the past and can you discuss some of the
- A. Broward County put me through hell. Living hell. Through depositions, they stated that I was not going to fuck up his case, they literally shoved pictures in front of me of Greeny in the

morgue. Those pictures I still see to this day.

- Q. When they say you were going to fuck up the case, what where they suggesting
- A. When I said that Lance did not fire a shot, they said, I'm not real ____, how else done it. Who else you think done it? You want to see some pictures, who else do you think done it, so that's when they brought out Greeny's pictures and showed me him in the morgue. And I would not know how to express that again, I very seldom go to Broward for those reasons, if I am going through Broward its fast and in a hurry and those images will stick with me until the day I die.
- Q. Now, so they basically, when you went to go give depositions and statements, they didn't
- A. They did not want anything but what they wanted to hear period. It was like nothing would change their mind, this guy didn't do it, but this guy done it and that was the bottom line, what I had to say, I mean, they did not want to hear anything opposite of that. And they wanted to hear he done it, and that was it, they wanted, I'm telling them I didn't that first shot, ya know, they don't want to believe that. Or they don't want to believe that period. They wanted someone to suffer for the crime of which them losing a fellow officer which I totally understand and I live with this guy blood on me and I will until I die. Ya know his family ____ the old injuries everyday, but I'm not saying that I don't want nothing to be _____ because I had a sexual relation and the possibility of him being the father of my child but that's more blood on me.
- Q. I am going to take a break right now, the time is 5:59 p.m.
- Q. My name is Jody Stacy and we are resuming the interview with Kay Allen, the time is 6:02 p.m. on October 21, we can start right back where we were, when you were saying that Broward County Sheriff's were giving you a hard time, when you were telling them about Coleman being the aggressor, what were their reactions.

- A. They didn't want to hear it from me, that was their reaction. I told them they wanted to know who was the aggressor
- Q. Right now we are at Kay's residence, and someone just pulled up so we are going to have to stop. Again, the time is 6:03 p.m.
- Q. My name is Jody Stacy and we are going to resume the statement of Ms. Allen, and the time now is 6:20 p.m., and again before we got interrupted, someone came to the house to fix her phone but we were hitting on how you were teiling BSO in your statements that Coleman was the aggressor and you were going to tell me that they did not hear I guess basically, can you tell me how they reacted to you ____ Coleman.
- A. When I was informing them that ____ Coleman and I wasn't down with it, I wasn't gonna do that, Wayne called me a bitch and insisted on doing what he set out to do by him, I guess, I don't know, all I seen was that he wasn't backing down from noone. When I informed Broward County of that they literally did not want to hear it, in no way shape or form, they did not want to hear that it was Wayne who wouldn't bow, it was Wayne that fired the first shot of what took place, Wayne is whom I feared by life from and I don't know, they didn't want him to be in existence, it was like they did not want him to be a part of it, they wanted to put it all on Lance. Which at the end, they ended up doing that.
- Q. Now they filed perjury charges on you?
- A I recanted everything that I had testified on, I recanted it. Being that I realized that I was literally their guinea pig, saying that meaning regardless of how I live the rest of my life, carrying all of this guilt, destroying other lives in the process, I just couldn't continue with what they had wanted.
- Q. And what did they want?

A.	They didn't want me to say a thing about, they only wanted to me to say that Lance was
	the aggressor, when he wasn't.
Q.	And I guess they, do your depositions, they ended up having to say that, and then you came
	into court and said no that was not the truth because you, where you in fear of BSO
A.	I still am, I still am. Like I said before, I very seldom go to Broward, even drive though
	Broward very seldom that made my life a living hell. Noone cared about me and they
	never will. All they wanted to do was get someone, get the person responsible for killing
	Greeny of which I understand, but use me in the process of doing so. They make their own
	rules and laws and regulations and that is it. And whoever is in the process, they don't give
	a damn about them.
Q.	Is there anything you would like to say on the behalf of Lance as far as how you feel maybe
	his sentencing should be or your relationship as this has happened, after this is all happened
	or anything of that nature?
A.	I don't believe he deserves the death penalty,
Q.	Do you feel that he came there that night to kill officers, to shot
A.	I know he did not, he always carried weapons for his safety, he was a business man, he
	always believed someone was after him, I think he came to kill anyone. Like I said before,
	Lance was just at the wrong place with the wrong person that night. People and
	never ever once tried anything. He sat inside of the restaurant while I counted that money
	in the office, he never tried anything.

Q.	Then was he doing pretty good with his business as far as, I mean he could take care of
Q.	Then was he doing pretty good with his business as far as, I mean he could take care of himself like he was taking care of his needs as far as food and shelter.
A .	himself like he was taking care of his needs as far as food and shelter.

he was having a hard time. He took care of his family, done several things for me, but I never seen where he was struggling for anything.

Did he give you money for bills and rides to work and

Rides to and from work, money, whatever ______. On the other side, I seen, that was it.
